# **RIGHT-OF-WAY EASEMENT**

# WITNESSETH

That the Grantor, for and in consideration of the sum of Ten dollars (\$10.00) and other good and valuable consideration, paid to the Grantor by the Grantee the receipt and sufficiency of which is hereby acknowledged, hereby grants unto the Grantee, its successors and assigns, a perpetual public easement for the construction, operation and maintenance of a public road, sidewalks, and other appurtenant facilities for public use (hereinafter referred to as the "Facilities") upon and across the following described lands (hereinafter referred to as the "Easement Area") located in Wakulla County, Florida, to wit:

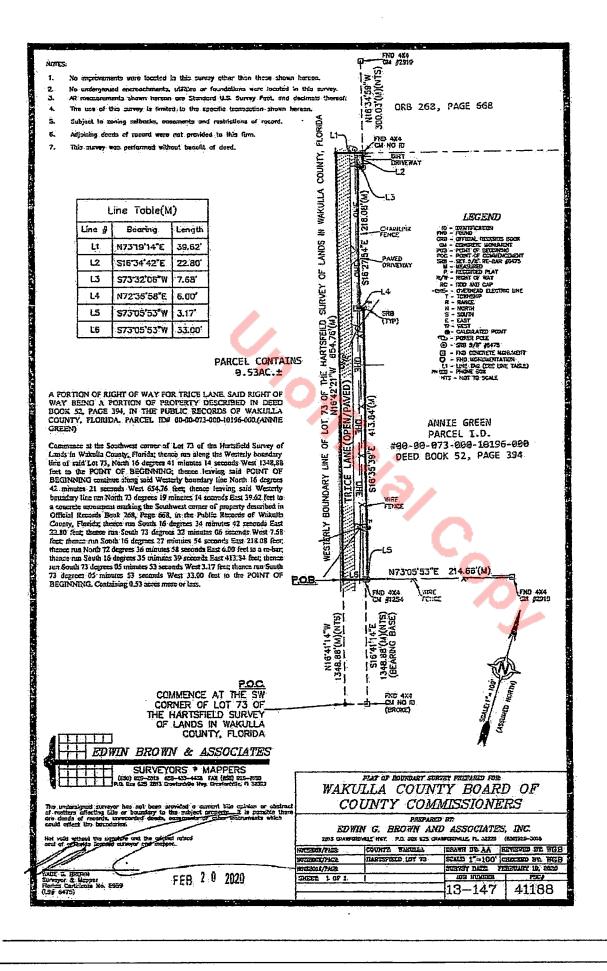
