RESTRICTIONS FOR HOCKINGBIRD HILL SUBDIVISION

Notice is hereby given by Richard L. Gowdy, the developer of the lands described as Hockingbird Hill; for the purpose of protecting values, these restrictive covenants shall be enforceable in the Mockingbird Hill Subdivision in Wakulla County, Florida.

- 1. Only one dwelling house or double-wide mobile home shall be placed upon any one lot in this subdivision.
- Each mobile home shall have skirting all the way around said mobile home.
- 3. No avine shall be allowed on any lot in the subdivision.
- 4. No lot in said subdivision shall be further subdivided.
- 5. All garbage shell be deposited at county approved dumps.
- All lots shall be kept free of overgrown weeds, eyesores, nuisances, or any items or activities which disturb the peace and quiet enjoyment of the neighborhood.
