SPECIAL WARRANTY DEED

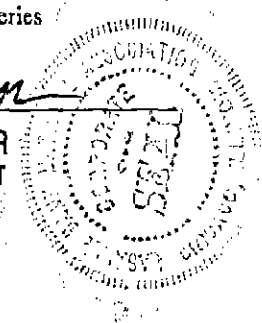

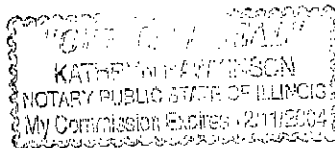
