THIS WARRANTY DEED Made the 22nd day of December, 2003, by

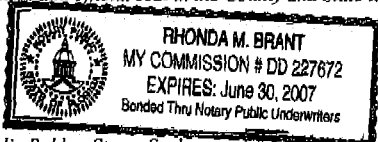
