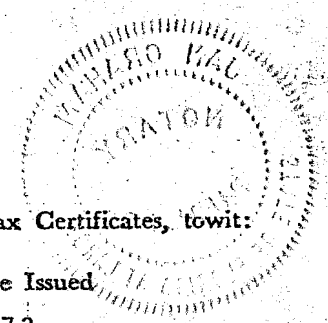


TAX DEED

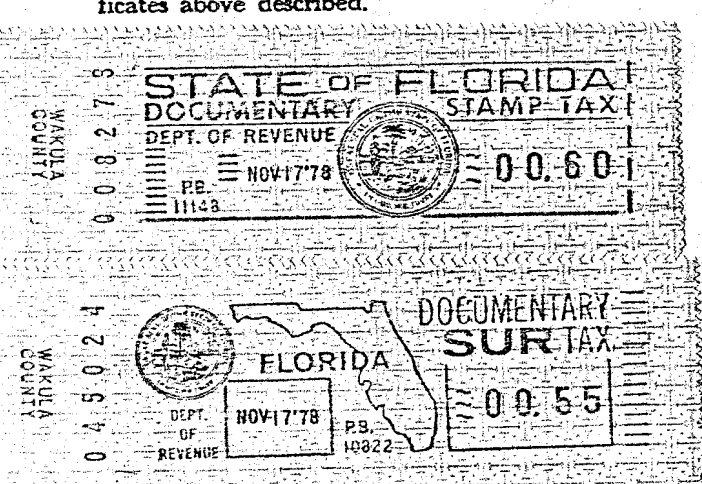

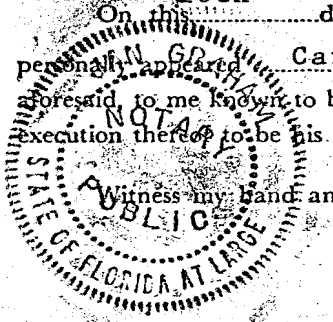

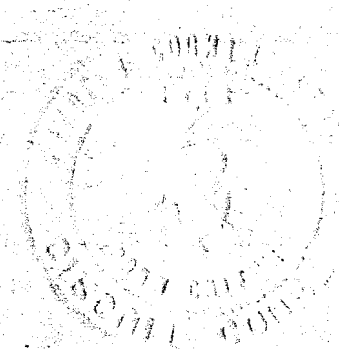
