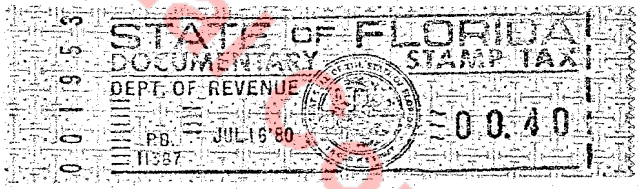

Witnesseth, That said grantor, for and in consideration of the sum of Ten - - - - - Dollars,

and other good and valuable considerations to said grantor in hand paid by said grantee, the receipt whereof is hereby acknowledged, has granted, bargained and sold to the said grantee, and grantee's heirs and assigns forever, the following described land, situate, lying and being in Wakulla County, Florida, to-wit:

Commence at the southeast corner of Lot 81 of Hartsfield Survey of Lands in Wakulla County, Florida, and run thence South 72 degrees 33 minutes 13 seconds West 278.99 feet along the south line of said Lot 81, H. S., to the point of beginning. From said point of beginning, run North 18 degrees West and parallel to the east line of said Lot 81, H. S., 414.77 feet to a point, thence run South 72 degrees 05 minutes West 88.59 feet to a point, thence run South 18 degrees 00 minutes East 414.03 feet to a point on the south line of said Lot 81, H. S., thence run North 72 degrees 33 minutes 13 seconds East along said south line of Lot 81, H. S., 88.59 feet to the point of beginning, containing .84 acre, more or less, in the Southeast Quarter of Lot 81 of Hartsfield Survey of Lands in Wakulla County, Florida.
