THIS WARRANTY DEED Made the 30th day of October, A.D. 2009, by **STUART KORTE*** and **KIMBERLI L. 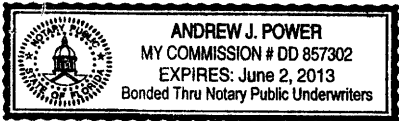
