

QUIT-CLAIM DEED

DORIS B. POULOS, the Quit-Claimor, in consideration of the sum of One (\$1.00) Dollar and other valuable considerations, hereby quitclaims unto ROBERT H. STONE, the Quit-Claimee, all her right, title and interest in and to the real property in Wakulla County, Florida, described as:

Begin at the northwest (NW) corner of the land sold to Davis Raker by I. B. Raker and wife, Edna Raker, and run North (N) one hundred (100) feet, then run East (E) one hundred fifty (150) feet; then run south (S) one hundred (100) feet to the land so deeded to Davis Raker by the said I. B. Raker and wife, Edna Raker, then run West (W), along the North (N) line of the said Davis Raker land, to the place of beginning, being in Lot seventy-seven (77) of Hartsfield Survey of lands in Wakulla County, Florida.

ALSO:

Begin at the Southeast corner of the land deeded to Mrs. Zelma L. Pararo by Mrs. Florida Raker and L. H. 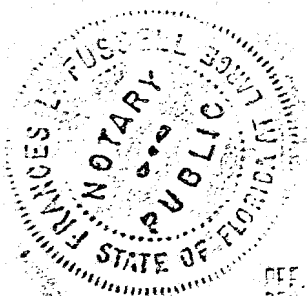
